Member Services: NACEDA continued to grow usage of its Thriving Networks Organizational Capacity Assessment tool. Specifically designed for community development networks, the tool is a guide for NACEDA to target capacity building resources, training, and technical assistance to its members. The tool served two networks in 2018. NACEDA coordinated member caucuses in the South, Midwest, East, and West Coast, as well as a peer group for communications professionals. NACEDA provided almost 1000 hours of member services in 2018, surpassing its service goal by 25%.

4b (Code:) (Expenses \$ 28,299 including grants of \$ 1,000) (Revenue \$)

Summit: NACEDA's 10th Anniversary Summit was held on September 12-14, 2018 in Philadelphia, Pennsylvania. This dynamic, peer-learning event was designed by and for state and regional community development association professionals. During 31 summit sessions, 110 speakers from across the country shared their successes and challenges on advancing policy initiatives, partnering with health providers, using arts and culture to engage communities, developing effective networks, and more. PolicyLink President & CEO Michael McAfee delivered keynote remarks, discussing strategies for building an equitable nation from the ground up. NACEDA released a new publication entitled Talking Values, and demonstrated how to use the publication to nurture conversations within the community development field. More than 200 registrants attended the summit, strengthening their networks of peers from across the country who work to advance prosperity in low-income places.

Per the by-laws, about one-third of the Board of Directors' terms end each year. The membership either re-elects expiring board members or nominates and elect new board members by majority votes at the organization's required annual meeting.

The board of directors is sent a draft of the 990 and a deadline by which to offer edits if there is significant objection to the document as written, the directors may choose Additional steps including assigning the 990 to a board committee or have a discussion at the next scheduled meeting of the board.

The Organization collects conflict of interest forms electronically from board members annually.

05. CEO, executive director, top management comp (Part VI, line 15a)

Compensation was determined by a variety of factors including market trends, budget, the candidate's skills, and the compensation level of NACEDA's previous Executive Director. The board also reviewed salaries of comparable organizations in Washington DC and around the country, including NACEDA's own members.

Explanation

Creative Placemaking: NACEDA's initial Creative Placemaking Immersion Program cohort concluded in 2018. The program began in 2016 with an ambitious goal: to make creative placemaking a frontline strategy for community developers. Creative placemaking engages communities in the using arts and culture to improve the physical and social character of places. The program funded a cohort of three NACEDA members - community development associations in Ohio, Massachusetts, and Philadelphia - to work with arts partners in their regions to build knowledge about creative placemaking among local community development nonprofits. The Ohio, Massachusetts, and Philadelphia Massachusetts networks performed robustly, providing 26 creative experiences to 275 people and organizations over 18 months. Artists engaged neighborhoods in development plans. CDCs became arts advocates. Banks became arts investors. NACEDA networks throughout the country began thinking how artists and cultural strategies could enhance the impact of traditional community development.
